The rules of the promo **Develop the Team together with Faberlic!**

1. General terms

1.1. A stimulating promotional event called

Develop the Team with Faberlic! (hereinafter referred to as the Promotion) is aimed at attracting new customers and increasing consumption of products under the FABERLIC trademark sold by the Organizer of the Promotion.

1.2. The Promotion Organizer: FABERLIC JSC

1.3. These rules of the Promotion (hereinafter referred to as the Rules) are posted on the official website of the Organizer of the Promotion. www.faberlic.com (hereinafter referred to as the Site).

1.4. The participants of the Promotion are users signed up on the Website (registration conditions are posted on the Website).

1.5. Promotion for new Customers is a motivating event for new customers. The terms of this event are posted on the Website. It is carried out in each catalog period, in addition to the current Promotion. The list and validity periods of the catalog periods are indicated on the Website.

1.6. Health Points are a numerical indicator approved for each product from the Health category posted on the Website. Detailed information is posted on the Website in the Regulations on the loyalty program of FABERLIC JSC Differentiated discount.

1.7. If the terms of the Promotion are fulfilled, the Participant of the Promotion is given the opportunity to purchase at a price of 1 rub. Faberlic Home cutlery set for 6 persons.

2. Duration of the Promotion

2.1. The promotion runs from 00:00 am on July 27, 2026 to 11:59 pm on February 07, 2027.

3. The territory of the Promotion

3.1. The promotion is held on the territory of the Russian Federation. The promotion is carried out on the Internet (on social media at the discretion of the Organizer of the Promotion, etc.), as well as on the Website.

4. Rights and obligations of the Parties

4.1. The participants of the Promotion, their rights and obligations:

4.1.1. The participants of the Promotion have the rights and duties established by the law of the Russian Federation and these Rules.

4.2. The organizer of the Promotion is obliged to:

4.2.1. To hold the Promotion in accordance with the procedure established by these Rules.

4.2.2. Provide an opportunity to sign up a Participant of the Promotion on the Website.

4.3. The organizer of the Promotion has the right:

4.3.1. To refuse a Participant of the Promotion who has not fulfilled or violated the requirements of these Rules to purchase a set of products specified in clause 1.7 of the Rules.

4.3.2. To change these Rules or cancel the Promotion. At the same time, the notification of the Participants of the Promotion on the Website about the change of the Rules or cancellation of the Promotion is made in accordance with the procedure specified in clause 6.2. of these Rules.

4.4. The Organizer has the rights and duties established by the law of the Russian Federation, as well as these Rules.

5. Conditions of participation in the Promotion and obligations of the Participants of the Promotion

5.1. To participate in the Promotion and apply for the purchase of a set of products specified in clause 1.7. of the Rules, the Participant of the Promotion must comply with the requirements of clause 1.4. of the Rules, as well as perform the following actions sequentially:

- from 00:00 am on September 07, 2026 to 11:59 pm on September 27, 2026 (catalog number 13/2026)

A newcomer is considered to be a Participant in the Promotion for new Customers Promotion.

5.1.3. Each catalog period:

- from 00:00 am on July 27, 2026 to 11:59 pm on August 16, 2026 (catalog number 11/2026)

- from 00:00 am on August 17, 2026 to 11:59 pm on September 06, 2026 (catalog number 12/2026)
- from 00:00 am on September 07, 2026 to 11:59 pm on September 27, 2026 (catalog number 13/2026)

place and pay for orders with a total of 25 Health Points and above on the Website.

(If the Participant of the Promotion has not placed an order for 25 Health Points in any of the catalog periods, then you can place orders in the next period. In total, for three catalogs No. 11/2026, No. 12/2026 and No. 13/2026, you need to score at least 75 Health Points).

5.2. A participant of the Promotion who fulfills the conditions of clause 5.1 of the Rules gets the opportunity once (regardless of the number of Newcomers who fulfilled the conditions of the Promotion for new Customers and personally scored Health Points) to add to the order at the Personal promotions tab from 00:00 am on October 12, 2026 to 11:59 pm on February 07 2027, the set specified in clause 1.7 of these Rules.

5.3. The dates are indicated in Moscow time.

6. The method and procedure for informing about the terms and conditions of the Promotion

6.1. The rules of the Promotion in full for public access are posted on the Internet on the Website.

6.2. In the event of a change in the Rules or cancellation of the Promotion, information about this will be posted by the Organizer in advance on the Website.

6.3. The Organizer of the Promotion has the right to use additional means not specified in clause 6.1. of these Rules to communicate to the Participants of the Promotion an offer to participate in the Promotion, accompanied by a brief statement of the terms of the Promotion, but indicating the location of these Rules (Website).

7. Additional Terms and conditions

7.1. The fulfillment of the conditions of section 5 of these Rules implies that the Participant of the Promotion is familiar with and agrees with these Rules.

7.2. The Organizer of the Promotion, as well as the persons authorized by it, are not responsible for technical failures in the network of the Internet provider to which the Participant of the Promotion is connected, which do not allow to complete the task for participation in the Promotion; for actions / omissions of the Internet operator to which the Participant of the Promotion is connected, and other persons involved in the process of completing the task to participate in the Promotion.

7.3. The Organizer of the Promotion, as well as the persons authorized by it, are not responsible to the Participants of the Promotion for not informing the Participants of the Promotion with the results of the Promotion, as well as for non-fulfillment (untimely execution) The participants of the Promotion have obligations stipulated by these Rules.

7.4. The Organizer of the Promotion is not responsible for any consequences of the Participant's mistakes, including (but not limited to) the costs incurred by the latter.

7.5. All Participants of the Promotion independently pay for all expenses incurred by them in connection with participation in the Promotion (including, without limitation, expenses related to Internet access), except for those expenses that are explicitly specified in these Rules as expenses incurred at the expense of the Organizer of the Promotion.

7.6. If for any reason any aspect of this Promotion cannot be conducted by the Organizer of the Promotion as planned, including reasons caused by force majeure, computer virus infection, Internet problems, defects, manipulation, unauthorized interference, falsification that distorts or affects performance, safety, honesty, integrity or The Organizer of the Promotion may, at his sole discretion, cancel, terminate, modify or temporarily terminate the Promotion.

7.7. The Organizer of the Promotion, in case of detection of persons violating the requirements of these Rules and / or the rights of other Participants of the Promotion or third parties, may refuse such persons to participate in the Promotion, prohibit further participation in this Promotion to any person who fakes or benefits from any falsification of the application process for participation, or the holding of the Promotion, or acts in violation of these Rules, acts in a destructive manner, or carries out actions with the intent to annoy, insult, threaten, or harass any other person who may be associated with this Promotion.

7.8. All controversial issues related to this Promotion are regulated on the basis of the law of the Russian Federation.

7.9. The terms used in these Rules apply exclusively to this Promotion.

8. Personal data

8.1. The participants of the Promotion (Personal data subjects), when registering on the Website, provide the Organizer of the Promotion with their personal data: full name, mobile phone number, address, etc. (the full list of personal data provided is indicated on the Website).

8.2. The information provided relates to personal data and is protected in accordance with the law of the Russian Federation.

8.3. Purposes of personal data collection

Personal data is collected for the purpose of registering a participant in the Promotion on the Website, organizing promotions, and providing Participants who have fulfilled the terms of the Promotion with the opportunity to purchase FABERLIC products specified in clause 1.7. of the Rules, at a price of 1 rub., sending messages to the Participant of the Promotion regarding the Promotion, promotional offers, communication with the Participants of the Promotion, as well as for the purpose of conducting marketing analysis and preparing statistical information, performing the function of a tax agent (if necessary, in cases provided for by the law of the Russian Federation).

8.4. The fact of signing up the Participant of the Promotion on the Website confirms the Participant's consent to provide the Organizer with their personal data specified in this section, their processing (including collection, systematization, accumulation, storage, including in case of claims), clarification (updating, modification), depersonalization, blocking and destruction, as well as for individual communication with the Participants of the Promotion.

The participant of the Promotion agrees to the processing of their personal data from the moment of registration on the Website until the day of its withdrawal.

8.5. Conditions of Personal Data processing

Personal data obtained with the consent of the personal data subjects is entered by the Organizer into a specially protected database.

The processing of Personal Data may be carried out by the Organizer personally, as well as by persons authorized by it (with the consent of the personal data subject).

The processing of Personal Data can be carried out using automated data processing tools, as well as non-automated ones.

Personal data may be transferred from the Organizer to third parties engaged by it on the basis of relevant agreements. An essential condition of the contracts concluded by the Organizer with third parties is the obligation of third parties to ensure the confidentiality of personal data and the security of their processing, as well as the consent of the subject to transfer his personal data to third parties.

The Organizer, who has access to personal data, ensures the confidentiality of personal data in accordance with the procedure established by law.

The Participant's personal data is stored in the database from the moment of registration of the personal data subject on the Website until the date of their withdrawal by the personal data subject.

8.6. The right of access of the personal data subject to their personal data

The subject of personal data has the right to receive information about the Organizer, about its location, about the availability of personal data related to the relevant subject of the Organizer, as well as to learn such personal data in writing (upon request, containing the number of the main document certifying the identity of the subject of personal data or their legal representative information about the date of issue of the specified document and the issuing authority, as well as the handwritten signature of the personal data subject or their legal representative), and orally by telephone.

The Participant of the Promotion has the right to obtain other information about the person who processes the Participant's personal data, in accordance with Federal Law No. 152-FZ On Personal Data by contacting the Organizer of the Promotion.

8.7. The Participant of the Promotion agrees to receive information about any current and new promotions of the Organizer and its affiliated companies by mail, phone, text messages or in the text of emails. The specified consent is given by the Participant of the Promotion for the duration of the Promotion and until the day of withdrawal of consent by the participant of the Promotion.
